PRESIDENT'S REPORT

It is my pleasure to present this annual report to the members of the Vermont South Club for the financial year ending June 2015. The club has once again been through a year of consolidation in many areas, with membership currently at 491 members, down just slightly from last year's total of 497. Both the tennis and bowls sections lost a small number of members whilst the darts section improved by 5. As in the past, all sections will continue to promote the club to the local community via open days etc., but the best method of recruitment is always by member recommendation. Be proud of your club and invite friends and neighbours to see what a great club we have.

Over the past months committee members have been in detailed talks with the Whitehorse Council regarding the lease of the Club, we are getting close to achieving what should be an good result ensuring the long term future of the Club.

I am sure all members will be pleased to see the strong financial position of the Club, with a surplus for the year of just under \$50,000. The first priority of your committee is to be financially prudent and to ensure funds are available to meet all commitments and future projects. We have an existing long term loan of \$240,000+ with the Bendigo Bank this is guaranteed by the council. Under our new lease conditions there will be more controls required by the council in regard to maintenance and that will mean additional cost to the Club.

Your committee of management is always looking at future projects to improve the facilities for the benefit of all members, this year we have seen the introduction of acoustic tiles on the ceiling in the lower clubhouse and a new storage shed on the upper clubhouse constructed. Under consideration at the moment are all weather shelters to both bowling greens and also the total redevelopment of the BBQ area. Hopefully with council participation, an extension to the current green house and maintenance shed will be investigated, this will involve us being able to secure a small parcel of extra land from the council, as plans for all these are developed they will be displayed within the Club. These projects are in addition to the planned replacement of our two greens. All projects are being costed into a ten year forecast to ensure that our financial position remains strong.

Your committee is always looking at improving our facilities and welcomes any input from members.

Sponsorship and fundraising has been managed by Neil Cameron who has done an outstanding job. His management of our sponsors and special efforts such as the Op shop and Bunnings has produced a magnificent result for the Club.

It is good to see the Tennis section starting to have regular committee meetings and putting a good structure of management in place, as in all sections of the club it is important the members contribute to the running of the Club by undertaking positions of responsibility. If many members become involved it makes light work for all. The Tennis section had mixed results in competition this past year with 5 senior teams representing the club on Saturdays and we saw two mid-week ladies teams making the finals. It is good to see all the players are enjoying the competitions. The club coach Jessica O'Meara has a great impact around the club with many innovative programs to attract new members to the club.

We saw a good result from the bowls section in pennant this year with one Saturday team and four mid-week teams making the finals resulting in one flag for the club. The level in participation is very high with a large number of members involved in pennant competitions. It is good to see the games played in good spirit and visiting teams commenting on our friendly Club and our excellent greens and facilities.

Our Greens and gardens have never looked better and we are very fortunate to have so many volunteers willing to give their time to maintain and keep them in pristine condition. With Andrew Ross and his greens committee working hard to present our greens in top condition week after week our Club is now being recognised as a venue for District and State competitions.

Our gardens are a picture and this takes many hours of dedicated work the team of gardeners led by Viv and Noel Bennett, do a wonderful job.

Your Committee of management has worked throughout the year to ensure the smooth running of the Club. I make a special mention to Ian Bauer who retires from the committee this year after 12 years which included a number of years as Treasurer, well done Ian. Past presidents Mike Emery and John Temple have taken on the roles of chairpersons of the Tennis and Bowls sections. Their experience will be invaluable to ensure the smooth working of both sections but other members need to

assist them and start to volunteer for committee positions. They will both serve on the executive as representatives of their sections.

A special mention for our secretary Jim Baker who puts in many hours to make sure the committee runs smoothly, Jim has also been heavily involved with the new lease negotiations with the council, also our treasurer Gordon Russell has settled in to his role very well and is keeping a close eye on our finances.

All committee personal devote many hours to their role and their input ensures a well-run organisation and I thank them all for their contribution. As with all non for profit organisations the recruitment of volunteers is essential to the existence of our club, with nearly 50% of our total membership, with less than 6 years membership it is essential that these newer members become involved in the day to day operation of the club, many serving members on committees have been involved for 10-15 years and it is important that we see "fresh blood" with new ideas come on board to take the club into the future.

BOWLS SECTION REPORT

It is my pleasure to file this report. Firstly, allow me to congratulate the previous committee led by David Russell. The Club is in good shape thanks to their work. I can now assure you that your current committee contains people with a broad range of skills and know-how and is working well together as a unit. This gives me confidence for a positive future term of office.

Our membership numbers are holding steady. We recruited 24 new bowlers this year. As at 30th June, we had a total of 257 Bowls Section members which is 5 less than last year. As a direct result of an ageing member base, we are sadly losing more and more members because of ill health and death so it is critical that we at least match this growing loss of members with new recruits.

As a major part of our recruitment program, we held several Try Bowls Days where over sixty potential new recruits attended. They were given a tour of our facilities and were shown how to bowl by our coaches. Many joined up and moved on to formal coaching sessions. The welcoming attitude of our members and coaches is an important factor in our recruitment success.

Net revenue from bowls activities increased by \$14,080 as a direct outcome of successful tournaments, several corporate events, social committee functions, sponsorships, general fundraising and an increase in green fee revenue due to increased player numbers. This is an outstanding result achieved by a lot of hard work and dedication.

Our sponsorship and fundraising effort has again been very successful this year. Neil Cameron has recruited several new sponsors and has other companies in his sights. It is not easy to convince companies to invest in sponsorships so I commend Neil on a job very well done. Sponsorships and fundraising activities such as raffles, Bunnings sausage stall and the Op Shop generated in excess of \$35,000 this financial year which is a critical component of our overall revenue. It is important that sponsors get value for their investment in our Club so we are pleased that our members have supported our sponsors whenever possible.

Saturday Pennant provided a mixed bag of results. Our top side finished in 2nd place after the home and away games and was our only team to make finals. Unfortunately, our side lost a close match at home to a fast finishing Upwey-Tecoma. Our other 5 sides finished well down the ladder with two sides being relegated to a lower division next season. Perhaps this poor result is due to dwindling player interest in pre-season and regular team practice or due to the significant number of players who were unavailable during the season which has an adverse impact on team stability and competitiveness, particularly in the lower sides. A much better attitude and commitment is needed if we are to be

successful in Pennant next year.

Our Midweek Pennant sides fared much better. We had 7 sides competing in Midweek Pennant and 4 sides made it through to play finals. Our Division 4 Side won their section flag and will be promoted to Division 3 next season. Overall this was a very rewarding result especially as the 3 sides that did not make finals were also quite competitive in their divisions.

Several Pennant players reached significant milestones during the season. Pat Andrew and Jan Stackpoole chalked up 200 Games in Midweek Pennant while Paul Drew, Paul Dunn, Graeme Durrant, Graeme Marchment and Ray Watson achieved 200 games in Saturday Pennant. Congratulations to you all.

We entered just one Night Pennant side this year and, although we had a slow start to the season, we had a great finish in winning our last six matches including some solid away victories. The side finished third and it should be noted that we never lost a home game all season.

Social bowls flourished yet again due in no small manner to the energetic organisation of convenors and helpers. I am sure that all social bowlers, including a significant number of visitors, enjoyed the games throughout the year. The best attended sessions each week were Wednesday Triples, Thursdays run by Ray Spelman and Monday pairs during winter run by Mal Walker. The monthly Sunday bowls and Dinner events were also popular.

Our coaching panel, led by Geoff Bryant, has been busy preparing new bowlers and providing opportunities for player development. Although many of our coaches are newly accredited, they have solid bowling experience, excellent bowling skills and a passion to help members at all levels. Regular skills sessions with specialised training drills were conducted throughout the year. They were well attended and resulted in improved capability for all who participated. Anyone wanting to improve in a specific skill area is encouraged to organise time with our coaches because constant improvement helps the individual bowler and also the Club.

The Tournament Committee has been very active and successfully coordinated a season of social bowls, tournaments and club championships. Gary Simmons has developed the annual Pro-Shot Tournament into a major event for the Club. Likewise, Val Weight excelled in coordinating the annual Gala Day which returns good income to the Club. The annual Mulgrave Country Club Challenge with 128 players filling both greens was another highlight of the year.

Andrew Ross and the greens team have worked diligently to provide greens of a high standard. Our greens achieved excellent ratings from Bowls Victoria and

are a credit to the team who spend many hours each week preparing them. I often get unsolicited comments from visiting players about the quality of our greens and there can be no better commendation than that.

The garden group headed by Viv and Noel Bennet have also done a fantastic job presenting our gardens in a very attractive fashion which enhances the overall appearance of our property.

Congratulations to all Club Championship winners and competitors. All events were well patronised and furiously contested with the result that very worthy winners were found in all categories.

special needs participants, some of whom are real characters. Particular mention needs to be made of the work done by Bernadette Ross and Margaret Sampson in organising this worthwhile community service.

Looking to the future, the Bowls Section is working on a "Development Plan" that covers all aspects of our operations e.g. membership, competition bowls, social bowls, administration, facilities and Club culture with the aim of turning a very good bowls club into a great bowls club. With the support of members, we believe this dream can come true.

I wish to express my thanks to our current Committee of Management who are working tirelessly together and are dedicated to the achievement of successful outcomes for the Club. I must make special mention of our Secretary, Keith Horlock who has a huge capacity for work and always delivers with great accuracy and thoroughness. He has officiated through a period of many changes and has introduced many new systems. Through it all, he has performed magnificently.

We also have many sub-committees who work diligently to make this Club run smoothly and efficiently. Our Bowls Club simply could not exist without the time, effort and skill contributed willingly by our volunteers. I have mentioned some by name in this report but that only scratches the surface. No matter whether working on a committee, convening events, visiting sick members, catering, maintaining our facilities or working for the Club as a casual volunteer, everyone's effort is valued and appreciated by the Club. 

Coaching

It has been a great 2015 season for Tennis. We have had great success, progress and growth across the board in all programs this year. Despite the cold weather it hasn't stopped a lot of our players developing their game in training. We have approx. 130 players coming regularly to tennis each week, started 2 new programs this year: 6 week 3-4 year old programs and 6 week adult programs to suit all ages and abilities. We also have our regular hot shots programs (5-12yrs), junior groups, squad groups, private lessons and cardio groups.

We have had quite a few junior players develop their game even further by taking on extra sessions per week, playing in 5ETS internal tournaments, playing Australian ranked tournaments and pushing their development into a more senior level of play. There are now quite a few young role models at the club which helps inspire everyone to get the most out of themselves.

With our wonderful coaches: Luke Bratchford, Joseph Sanchez, Joseph Pitt and Braydyn Chong we have really formed a great pathway for all players to successfully go from modified Hot Shots to Senior/ Professional tennis. All coaches regularly play a high level of Senior Club tennis, all of which made it to the grand final for the season. This helps them relate and encourage the players with a never give up attitude, sharing with them the tools to help them through the mental battles of the game.

The coaches have worked really hard and are progressing their own skills to enthuse players on and off the court. We would like to congratulate Braydyn Chong for recently completing his Tennis Victoria's Future Leaders Program which is a 3 day camp for young players wanting to be leaders of their community. The program requires them to complete 40hrs community service which he has already put to use with a successfully run junior round robin tournament and the Women's Open Club championships for 2015. So look out for him around the club more.

This is 5ETS 3rd year at VSC and hopefully you have seen more activities around the club from cardio tennis that's going strong on Thursday nights, Sunday intra club orange ball comp with players under 12 to some off court fitness sessions there is a real buzz and energy that's great to be around. TREASURER'S REPORT

Once again we had a successful year financially. The surplus for the 2014/2015 financial year was \$49,837 compared with \$37,988 the previous year, an increase of \$11,849.

There were increases in Membership Fees (but fees were fairly even due to social membership and discounts), Corporate Events and Venue Hire. Income from Playing Fees rose (primarily Bowls) whilst Tennis was steady overall. We had a good year with Fundraising with an increase in over \$1,000 raised, the Bar had a very good year with a \$5,000 increase both by patronage and corporate bar sales. On the expense side there was significant saving on Affiliation fees due to prepayment of Bowls fees in the previous year and a minor saving in the reduction of fees by Bowls Victoria tennis was fairly stable. Clubhouse Maintenance was again similar but there was an increase in Club House Maintenance due to painting of upper club house, installation of acoustic ceiling tiles and new storage shed facilities.

Cash on hand at 30th June 2015 is \$202,980 up by \$72,890 on last year. Whilst our cash balance looks fantastic, please note that we are reserving funds for upcoming asset replacements/upgrades in particular a new west green surface which, by itself, will cost in the region of \$180,000. Furthermore, we still have an outstanding loan from the Bendigo Bank the balance of which stands at \$243,379.

The Club remains in a sound financial position with the strong prospect of increasing its financial strength into the future. We look forward to the members' continued support to maintain our club's reputation as one of the premier sporting facilities in the City of Whitehorse.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

1.1 Basis of Preparation.

The financial report is a general purpose financial report that has been prepared in accordance with the Associations Incorporation Act 1981, as amended, and the applicable Australian Accounting Standards required by Schedule 1 of that Act for prescribed associations. The financial report has been prepared on the basis of going concern and historical cost conventions. The accounting policies are generally consistent with those of the previous period except where detailed otherwise in these notes.

1.2 Inventories

Inventories are recorded at the lower of cost or net realisable value.

Cost is based on first-in first-out cost method and includes expenditure incurred in acquiring the stock and bringing them to the existing condition and location.

Net realisable value is determined on the basis of the normal selling pattern.

1.3 Property, Plant & Equipment

Items of property, plant and equipment including buildings and other leasehold property are recorded at cost less depreciation. As there is no expectation that existing leases with the Whitehorse Council will not be renewed, depreciation is applied on a straight line basis over the estimated useful life of the assets.
