## PRESIDENT'S REPORT



It is my pleasure to present this annual report to the members of the Vermont South Club for the financial year ended in June 2016.

The club has this year has continued to improve in many areas, with membership at 30<sup>th</sup> June showing 515 members, up from last year's total of 497, all sections saw an increase in members. As in the past all sections will continue to promote the club to the local community via open days etc., but the best method of recruitment is always by member recommendation, be proud of your club and invite friends and neighbours to see what a great club we have.

Over the past 18 months committee members have been in detailed talks with the Whitehorse Council regarding the lease of the club, recently we have finalised the process and are just waiting for council to ratify the lease. This new lease guarantees the future of the club for the next 15 years and beyond, we believe we have achieved a very favourable result for the club against what was presented to the club 18 months ago

I am sure all members will be pleased to see the strong financial position of the club, with a surplus for the year of just under \$55,000. The first priority of your committee is to be financially prudent and to ensure funds are available to meet all commitments and future projects. We have an existing long term loan of \$220,000+ with the Bendigo Bank, which is guaranteed by the council.

The committee of management is always looking at future projects to improve the facilities for the benefit of all members, under consideration at the moment are all weather shelters to both bowling greens, cover over the clubhouse Verandah and also the total redevelopment of the BBQ area. In the lease negotiations we secured a small parcel of extra land allowing us to upgrade the maintenance shed and green house if and when required.

We have approached the council requesting assistance for some of these improvements through their capital works program for the 2017-18 year and are awaiting their response, we also have applications in for government grants, but results will not be known for some time. We had hoped that we could have started some of the above projects during the last twelve months but the protracted lease negotiations have delayed them. Plans for all these developments will be displayed within the club when finalised.

We are working with the two neighbouring schools, council and state government to try to resolve the car parking problems around the club precinct, some concessions have been made by council and we will soon

see some restrictions removed in surrounding streets. We will continue to monitor the situation and keep working with all parties towards a long term solution.

We have appointed a consultant to completely redesign our web page this will give better access to members from all sections and encourage ease of use and more participation from the community.

During the year we also reviewed our member's accident cover to bring it up to date with current conditions and encourage all members to view the details which will be listed on our website.

All projects have been costed within a ten year forecast to ensure that our financial position remains strong, and these are in addition to the budgeted replacement of our two greens and normal tennis court maintenance. The committee welcomes any input from members with suggestions for any other improvements.

The tennis section is continuing to have regular committee meetings and we are all working towards putting a permanent structure of management in place, as in all sections of the club it is important the members contribute to the running of the club by undertaking positions of responsibility. If many members become involved it makes light work for all. The Tennis section has had good results in competitions this past year with teams representing the club on Saturdays, mid-week ladies teams, Monday night, and junior teams all making the finals and some winning their sections, good to see all the players are enjoying the competitions. Jessica O'Meara our club coach is continuing to work hard to introduce programs that will increase the level of participation and it is good to see the club championship's attracting good numbers.

We saw good results from the bowls section in pennant this year with one Saturday team and four mid-week teams making the finals, resulting in one division flag for the club. The level of participation is very high with a large number of members involved in pennant competitions, 7 teams in Saturday pennant and 8 teams in the mid-week pennant. The club has appointed a coach for this season who is introducing structured training sessions that will be aimed at improvement for all divisions, it is good to see the number of members taking advantage of these sessions.

As always our Greens and gardens have never looked better and we are very fortunate to have so many volunteers willing to give their time to maintain and keep them in pristine condition, with the greens committee led by Denis Quintal working hard to present our greens in top condition week after week. Our gardens are improving every year and this takes many

hours of dedicated work, Viv and Noel Bennett and their large band of helpers do a wonderful job.

Past president John Temple has been chairperson of the Bowls section and under his direction we have seen a renewed enthusiasm with many new innovations, John also spends many hours compiling and distributing our E-News which is an important means of communication within the club, I encourage every member to read the newsletter to keep up to date with club news, and also to contribute items of interest.

Our secretary Jim Baker works many hours to make sure the committee runs smoothly, he has also been covering the secretarial requirements for the tennis section in addition to his normal role of club secretary, we are hopeful to recruit someone to take on this role to lighten the load for him.

Neil Cameron has once again done an outstanding job with sponsorship, his management of our sponsors and special efforts such as the Op shop and Bunnings has produced another excellent result for the club.

Special thanks to Paul Dunn our membership officer who puts in many hours maintaining our membership records.

One of our major injections of cash comes from our bars in both the clubhouses, every year Jock Halley and the many members with RSA qualifications provide the refreshments after the game and for all the other club activities. Jock has managed the bar for many years and his careful buying ensures a good level of profit, thank you Jock for all the hard work.

I would like to thank the social committee who have arranged many activities throughout the year. The social side of our club such has always been very important as it allows members from all sections to meet and enjoy social interaction which in turn encourages participation in all club activities.

Your Committee of management continued to work throughout the year to ensure the smooth running of the club. A special mention of thanks to Gordon Russell (Treasurer) and Mal Walker (Vice President) who both retire this year after many years of service to the committee.

As with all not for profit organisations the Recruitment of volunteers is essential to the existence of our club, it is essential that newer members become involved in the day to day operation of the club. Many serving members on committees have been involved for many years, so it is pleasing to see members with new ideas coming on board to take the club into the future.

All committee personal and volunteers at all levels devote many hours to their duties and their input ensures a well-run organisation and I thank them all for their contribution, I hope they all get satisfaction for a job well done.

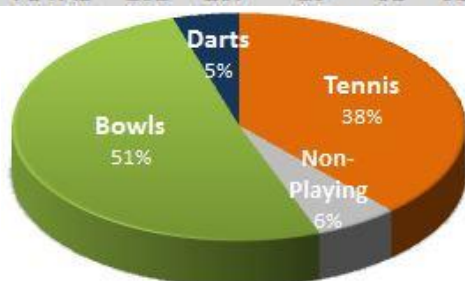

## BOWLS SECTION REPORT

It is my pleasure to report on the activities of the Bowls Section for the year past. I have had the privilege and benefit of working with a fabulous team of devoted volunteers, across all areas of the Club, who fully understand their responsibilities and perform their roles without fuss or intervention.

Perhaps the most important occurrence of the year was our decision to review the status and operations of the entire Bowls Section. We knew we had a very good Club but we wanted to explore how we could improve and develop into a great Club. Clive Wilson was appointed to lead this review and, after several months investigating, he delivered a detailed report to the Bowls Committee. The findings were accepted and presented to members at the Bowls Section AGM. The main recommendations were:

- ✓ Increase our profile and visibility in the Community
- ✓ Set a target of 275 members by June 2017
- ✓ Introduce better training and practice regimes
- ✓ Establish performance goals for Pennant teams
- ✓ Review Social & Tournament bowls
- ✓ Ensure everyone understands Club Mission and Values
- ✓ No increase in Membership Fees next year
- ✓ No review / increase in Green Fees until Sept 2018

Most of these recommendations have now been implemented or are on-track and the Club is now well placed to derive significant benefits.

As at 30<sup>th</sup> June, we had a total of 267 Bowls Section members which, pleasingly, is 10 more than last year. Unfortunately, we lost 16 bowls members but we recruited 26 new ones, Because we are seeing an increased number of retirements every year, we have to work harder to replace each and every one just to break even.

We heavily promoted Try Bowls Days early in 2016 and had about 40 potential new recruits attend. With enticing incentives to join, many subsequently signed up and attended formal coaching sessions.

The net revenue from bowls activities went up by \$7,200 over the previous year. This is a direct result of successful tournaments, social functions, sponsorships, corporate events, general fundraising and increased player numbers. This is another fantastic result achieved by the hard work and dedication of many members. There is no doubt that the Bowls Section is the financial engine of the Vermont South Club.

Sponsorships and fundraising activities are critical components of our overall revenue. I am pleased to report that our sponsorship and fundraising effort has



again been very successful this year. We strongly encourage all members to be aware of our sponsors and to support them whenever possible.

Our Saturday Pennant sides delivered mixed results. Our first side (Div 2) was the only one to make it to finals and then lost in the semi-final. Our second side (also Div 2) were extremely unlucky to just miss out on finals because of shot difference. All other sides finished mid ladder with no sides relegated.

Of our eight sides in Midweek Pennant, four sides played in finals, an excellent result for the season. Congratulations to our top Open side (Div 1) who won the Section Flag and also to our fourth Open side who gained promotion to Div 2 next season. Unfortunately two of our sides will be relegated next season. Interest in Midweek Pennant has never been higher.

Our Night Pennant side performed quite well particularly as it contained a mix of experienced and new players.

For the first time, we implemented an award for most valuable pennant player. Separate awards were made for Saturday and Midweek pennant competitions, each decided by votes lodged by opposition skips. The winners were:

Our Pennant selectors endured added difficulties this year with an overflow of players requiring implementation of a rotation policy. Nevertheless, they always selected teams with the best interests of the Club and individuals in mind.

Our signature tournaments (Gala Day and the Pro-Shot) were again highlights of the bowls year. Both were magnificently organised thanks to our Tournament Committee and especially Val Weight and Gary Simmons. Of course these events could not have worked without fantastic support by our Catering Teams.

Congratulations to Lorraine Bennett and Rick Carver for their individual success in winning their respective Regional Novice Tournaments and then for

progressing deep into the State level tournament. Lorraine eventually played off in the State Final and was Runner-up. This is a best ever result for our Club.

Our regular Social bowls programs and Sunday dinner events were quite well attended again this year. This is due, in no small manner, to the energetic efforts of committees, convenors and helpers. However, we feel that slight tweaking of timetables and game formats is required to keep the events fresh and attractive to members and visitors, so we will continue to review and modify our programs. The annual Mulgrave Challenge with 128 players filling both greens was also a very successful event.

Our coaching panel, led by Geoff Bryant, has been active teaching new bowlers and fine-tuning the skills of others. Our coaches have a passion to help members at all levels. Regular skills sessions with specialised training drills were conducted throughout the year and will be further enhanced this year.

We were offered an opportunity to secure the services of Lloyd Iaccarino as Head Coach of Pennant Bowls and grasped the opportunity with both hands, Although a non-playing role, this appointment fits neatly with our plan to introduce better training regimes. Lloyd has great enthusiasm and a strong desire to help our Club improve. His plan provides opportunities for players at all pennant levels to advance their skills

We also engaged the services of Lachlan Tighe, a highly credentialed international bowls coach, to deliver 7 x 2 hour sessions to our players over the pre-season. We fully expect this to be a huge advantage to those who participated.

After many years in the role, Andrew Ross handed over the reins of Greens Director to Denis Quintal this year. Our greens team continues to work diligently to provide greens of a high standard and we appreciate the time and effort they put in to the job. On the advice of our professional contractor, we decided to correct flaws in the sub-structure of our East Green which involved roll-back of the synthetic surface. Unfortunately, the outcome is not to our satisfaction and more work needs to be done by the contractor.

Similarly, we appreciate the work done by our gardening team headed by Viv and Noel Bennett. They ensure our gardens are presented in a very attractive fashion which enhances and beautifies our property.

Our Social Committee again delivered a jam-packed program of social activities. The major event was the end-of-season trip to Echuca. Thanks to everyone who organised, supported and helped out with these functions and to those who donated prizes.

Congratulations to all of our Club Champions and to those who contested the events. All categories were well patronised and intensely contested.

All teams did extremely well, with 3 teams making the semi-finals, 2 of which made grand finals for their section with one team taking home the Pennant.

We now have 10 senior teams competing over Summer 2016/17 with many first time senior comp players and new members. Naturally this also became a mathematical nightmare with the 6 available tennis courts (1 social tennis court) so we have taken up an alternate venue court hire at St Christopher's Tennis Club on Blackburn Road, where one team rotates to play at each week. We are three weeks into the season and so far this has worked well with all matches being able to finish on time.

With that I will now handover the rest of the senior competition duties to our new senior convenors Braydyn Chong and Joseph Pitt. I congratulate them on stepping up after participating in the Tennis Victoria Future Leaders Program, a program that I was also apart of back when I was a junior player. I will continue to support them and wish them good luck in their new roles and am sure they will continue to do a fantastic job of helping the senior tennis section grow further.

## TREASURER'S REPORT

Once again we had a successful year financially. The surplus for the 2015/2016 financial year was \$54,629 compared with \$49,837 the previous year, an approximate increase of \$5,800.

There was an increase in Membership Fees (but fees were fairly even due to social membership and discounts), but Corporate Events and Venue Hire were down about \$3,000. Playing Fees income rose (primarily Bowls) and whilst Tennis had quite a reasonable rise in income – a little over \$1,100 plus arranged a \$3,000 sponsorship for Junior Tennis. We had a good year with Fundraising with an increase in over \$25,000 raised (primarily different reporting but also really good effort from the social committee). The Bar had a good year but with a \$500 decrease caused by extra stocking of bar prior to Jock going on holiday. On the expense side, Affiliation fees for Tennis and Bowls were about what was expected. Clubhouse Maintenance was down with just regular maintenance being performed – no major works at all

Cash on hand at 30<sup>th</sup> June 2016 is \$279,789 up by \$76,809 on last year..

The Club remains in a sound financial position with the strong prospect of increasing its financial strength into the future. We look forward to the members' continued support to maintain our club's reputation as one of the premier sporting facilities in the City of Whitehorse.

**NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES**

**1.1 Basis of Preparation.**

The committee has determined that Vermont South Club Inc. is not a reporting entity and accordingly, this financial statement is a special purpose financial statement prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act (VIC). The committee has determined that the accounting policies adopted are appropriate to meet the needs of the members.

The financial report has been prepared on an accrual basis and under the historical cost convention, except for certain assets, which, as noted, have been written down to fair value as a result of impairment. Unless otherwise stated, the accounting policies adopted are consistent with those of the prior year.

The accounting policies that have been adopted in the preparation of the statements are as follows:

**1.2 Inventories**

Inventories are recorded at the lower of cost or net realisable value. Cost is based on first-in first-out cost method and includes expenditure incurred in acquiring the stock and bringing them to the existing condition and location. Net realisable value is determined on the basis of the normal selling pattern.

**1.3 Property, Plant & Equipment**

Items of property, plant and equipment including buildings and other leasehold property are recorded at cost less depreciation. As there is no expectation that existing leases with the Whitehorse Council will not be renewed, depreciation is applied on a straight line basis over the estimated useful life of the assets.

**1.4 Depreciation**

Depreciation charge is a charge against the Net Income of the Club. Estimates of remaining useful lives are made on a regular basis for all assets, with annual reassessments for major items.

The Statement of Financial Performance for the Year Ended 30 June 2016 reflects the normal accounting treatment.

**1.5 Goods & Services Tax**

Transactions are recognised net of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.

**NOTE 3: Bendigo Bank Loan Account**

The loan from the Bendigo Bank is secured by a guarantee for advances given by the Whitehorse City Council in favour of the Bendigo Bank, to cover borrowing by the club for the development of the Club House and the new green for a term of 20 years. The Club has not provided any security to the Council for its provision of the guarantee, other than that covered by the lease from the Council to the Club for all of the Club's improvements at Charlesworth Park.
