## VERMONT SOUTH CLUB PRESIDENTS CLUB REPORT 2018 / 2019

Every year we ask, where has the year gone - quickly again. First thing I would like to mention is the magnificent job all our volunteers have done again this year. It has been a huge year with plenty of things happening and you just can't appreciate how

a club would move forward without all of the great helpers we have. Tennis, bowls and darts collectively are all magnificently served by these great people. You should all be proud of yourselves and be happy that your contribution is so important for our long term future.

The club is growing, and as we get older we have people replacing those who can't join us on the tennis courts, bowling green or at the dart boards. Replace, does not mean our elderly members moving on it means enjoying what the club has to offer after they finish their playing days.

As you are aware we were able to secure a \$300,000.00 grant from the Federal Member for Deakin, Michael Sukkar. This has been confirmed and was always in the Federal budget and is available to us until 2026. We are now working with council to complete architect's drawings so as we can have the overall cost of our extensions submitted for consideration in the City of Whitehorse 2020 budget. Included in the extension is provision for a members lounge. A place where all members will be able to play cards, watch TV, have a coffee or other refreshments, you will be able to read books from an updated library etc. So something to look forward to for everybody. Playing or non playing.

We are looking at upgrading the tennis court lighting. There is a lot of work going on to firstly get some costings completed then get this project completed as soon as possible.

With the delay of our extensions taking place it enabled us to bring forward the replacement of the Ryman Green. We had some contamination in the bottom left hand corner as well as the green deteriorating in other places. Our thought process was that it had to be replaced at some stage in the not too distant future so why not now, particularly when we are now a division one club and secondly, the money we were investing into the extension was not required, so we were able to channel funds into the Ryman Green project. It was completed in August with plenty of time for members to get a feel for it.

These things just don't happen. There was an enormous amount of work done by Denis Quintal and his team, Noel Bennett, Ron Vogle, Tony Bennett, Alan Rolfe, Barry Hockham and John Bennett to get the job done. We commissioned a working party, who literally spent hours putting a business case together for the committee to consider. When everything was taken into account, points for and against, it was unanimous that we proceed with the work. KCL won the contract and you can see the result.

Infrastructure is an important part of our existence and where possible we will meet all viable projects subject to us being in a sound financial position.

A couple of years ago the tennis club had a reinstatement, if you like, of their committee. It was thought that they should have autonomy and would be better served by those involved directly with the tennis club. Led by Damien Whaley and Libby Fergusson they have had a great year. They have eclipsed last year's financial position and have turned in more than a healthy profit. Of course a lot of that money is returned to the club itself by way of different items required to keep the place in top order. So far we have had new carpet laid and new tables being the larger items, and now we are looking at improving the lighting to encourage the current members to play on those nice warm balmy nights. Damien will no doubt talk about the on court effort in his report. Well done to all concerned and congratulations to the trophy winners in the club championships held recently.

Jess became a mum during the year with necessitated additions to her coaching team and a name change – We Are Tennis. Together with this Jess is working with Sean & Kylie Wilkenson both excellent players in their own right and top class tennis coaches. Good luck with the new venture. Your drive and enthusiasm does not go unnoticed.

The darts boys continue to enjoy their Thursday Nights, with good numbers each night. They are self sufficient and again are well served by their management team.

A number of them played Jack Attack and their team won the club challenge at the Dandenong Club a few months ago. Well done boys and we look forward to your involvement with the new competition beginning in a few weeks.

The bowling club again had a wonderful year. The senior team were the leaders in the clubhouse so to speak, with a great finals win that elevated us to Division One. However, all teams are to be congratulated on the their efforts throughout the year. In a close encounter out at Darebin, we were so close and yet so far, as we went down in the end to a pretty good Altona Club team. No doubt Michael Keel will give us a good measure of what we did in his report. That said, all of our coaches led by Lloyd and Max were fantastic and I'm sure we will benefit from their knowledge and ability to play the game in their own right. They will work together this year with Max having made a decision to play as well with us this season. Both are exceptional people and we are indeed very lucky to have them playing at Vermont South. Our other coaches have also played a pivotal role, weaving their magic to all new players and others who have requested assistance. I'm sure they would have passed on a lot of good information for us to learn from.

Lloyd, Max and a few others set about presenting a "Model for Division One " Chairman of Selectors, Alan Lamb & Andrew Ross, Michael Keel, Lloyd and Max were absolutely certain we had to move quickly. Shoring up our current list of players as well as bringing in new people to the club. This was paramount for our longevity. We also take this opportunity of congratulating Max on his magnificent win against the Australian Number 1 Aron Sheriff. Terrific effort and one that he will remember for the rest of his life.

With the promotion of us to Division One there are some new things happening. Again, I'm sure Michael will talk about these in his report. I believe these actions were mandatory in any event and will serve us well in our efforts as we continue growing.

After a round table discussion, the committee agreed unanimously to invest \$20,000 into the clubs ongoing development, which includes Coaching, Player Development, Marketing, Branding, Sponsorship and Social Media all of which are so important for us to be one of the leading clubs in the East. We therefore appointed Penny Knight to work with us in this area. Penny has a background in Marketing, Events, Sponsorship and Social Media. She has already met with the VSC committee where we have set some directives. The idea of Sunday Afternoon Entertainment was the first thing she thought we could do. "Sunday November 10<sup>th</sup> Jazz on the Green " is our inaugural day. She is also working with Damien to improve our website. The front door, so to speak needs to be active and attractive and tell the tale of how we operate without being too busy. Our sponsorship and is another item on her agenda. We are confident that Penny will raise the bar in this area which is pivotal to our revenue growth.

As previously mentioned, Coaching, Game / Player Development and Marketing / Sponsorship, Social Media are things we just have to do to ensure our future, so we need to use all the necessary tools to put ourselves out there and in front of the local community and others. Max is looking after game and player management. Part of his role will be to attract schools to our club by way of putting a competition together where 6 or 7 local schools will compete in a round robin series predominantly to introduce them to the games of tennis and bowls. (YEARS 10 - 12's). He will also look after recruiting. Not a lot has been put on the table as yet but planning has begun.

It is so important that all members understand that clubs such as ours have dwindling memberships. If we don't take affirmative action we will be close to nonexistent in time. Bennettswood is a prime example of a club who hasn't taken the necessary action to ensure its longevity. I'm led to believe they only have 2 Saturday Pennant teams this season. Arguably, one the best lawn bowl surfaces in the metropolitan area and they are basically on their knees. As a committee we cannot and will not allow this happen to us.

I am asking everybody to work with us to make sure we are still here in 20 years and beyond. As you can see we are working hard to develop an exciting club for new and older members. We will continue to take steps to do things that we believe are in the interests of all club members. At the same time these actions are taken with the knowledge that we are now and will continue to be financially viable.

To my hardworking committee. Thank you all for doing such a magnificent job. The job of president is made a lot easier with good people who work in harmony. There

should be robust debate and at the same time be able to sit down and have a beer after.

It is unfair to single out any one person because everybody is so important. However, The VP, Pauline Cullen has been great even though she loves her trips away with Phillip. She is still reachable and adds another voice toward what we want to do, playing devils advocate as well. Jim Baker, one word "FANTASTIC " not an easy job being secretary, but he is always on the mark, active and a great help. Martin Haynes, Treasurer another tough job. We discuss issues where spending is required and we have to be convinced any spending is controlled as well as looking at ways to increase revenue growth instead of going to the same well all the time. This is proven by no increased membership and little or no additional costs at the bar. Keeping on top of expenditure is key and Martin is certainly got it under control.

To those people who have the highest award bestowed upon them – Life Membership CONGRATULATIONS. This award has been earnt by you for the time and effort you have put into the club over many years. An accolade and at the same time saying thank you for your invaluable time.

Meritorious Service Awards. Your efforts have also been recognised and an award to say we appreciate everything you have done for us, whether it be one continuous task or many.

Finally, pushing the point, we are a club taking all necessary steps to secure our future. The Council have given us a wonderful accolade saying we are one of the most progressive in the municipality, and they have not 100% said no to a roof. I know, pie in the sky you might say, but you have to float these ideas or you aren't in the queue. We are determined to flourish and continue to build our membership and at the same time have our infrastructure equal to any other.

## **BOWLS SECTION REPORT**



We are now celebrating 25 years of the Bowling Club and are happy that our club, which started with such humble beginnings, is now one of the biggest and successful clubs in our region. So much hard work by many members over the journey has achieved this significant milestone. Congratulations to all our loyal members past and present who helped build and sustain our club over the past 25 years!

Continuing on from the previous year, we are a very healthy modern bowls club having embedded initiatives like the Jack Attack program into the bowls agenda, corporate bowls engaging local business / community, replacing the west green with a new artificial grass green, achieving divisional one ranking for our top Saturday Pennant team. All these initiatives are great achievements and a credit to the members who were involved. However, we can't afford to sit back as we must keep the growth momentum going ahead.

A challenge facing all bowling clubs, including us is the ageing of our members. Our older members who have been instrumental in building our club are still important but we realise that the level of involvement is not the same. New members are vital and we will be putting extra effort this year into our try bowls program, improving the marketing of the club in the community and our barefoot bowls initiative.

Bowls Club membership is 236 members as at of end September 2019, down from last year. This number is concerning and we know some members are yet to pay the annual membership. These members are being followed up and we will report the membership numbers in eNews during October / November. We cannot afford to be complacent and must always be on the lookout and act accordingly to attract new members to our bowling club.

We are very proud to be part of the local community and we have been recognised by the community receiving our second Deakin Community Award in two years. The Hon Michael Sukkar MP presented this and a Deakin Community Award to Jock Haley for the many years of volunteering managing all aspects of our bar. Other significant community fund raising included 'biggest morning tea" this raised and tidy sum for cancer research and the men's heath day raised funds for prostate cancer research.

Jack Attack, Barefoot Bowls and Corporate Bowls are great initiatives and our goal is to increases bowls participation, improve community awareness about our club and to appeal to younger players to have "a go at bowls"!

The income from these initiatives is shown in our Treasurer's report.

Our pennant teams were solid last season with five teams on Saturday playing in the finals, with the two teams who missed out having a competitive season and maintaining their division position. Our 4th, 3rd and 1st teams won promotion resulting in us having teams in Divisions 1,2, 3,4 and 5 for season 2019/20.

In Midweek Pennant we had three sides playing off in finals being sides in Division 1,2 and 3. This resulted in the third side being promoted to Division 2, which was a great result. We also had two teams that were relegated to a lower Division and all other with sides remaining at their current level. We now have sides in Divisions 1,2,3,4 and 5 for season 2019/20.

In Tuesday night pennant completion we finished in 3rd position – made the finals and were eliminated in the semi-finals. This season, if we have sufficient bowlers interested in playing night pennant over a 14-game season, we may be in a position to enter a second term.

We must acknowledge the support of the selectors who spent vast amount dedicated to select teams and manage emergency players when needed. Thank you to all of the selectors for their commitment to this import task and contribution to the success of our pennant teams.

Improving the skill levels, and understanding the tactics of a game is undertaken by the club's coaches. Led by our head coach, assisted by the team of coaches, regular skill base training sessions were held and one-one coaching guidance was available to all club members. The coaches did play an important role in the success of pennant teams and contributed to our try bowls program.

Our Green Team like so many of our volunteers, have a very important and specialised function by keeping the greens in top playing condition, which they do extremely well. Our west green – Ryman Healthcare Green has been replaced under the management of our greens director with a new artificial green supplied by KCL (vendor) who supplied the east green. This project was done on time and under budget. Funding /cost are shown in the treasurers financial report

We must thank our small band of gardeners and helpers who have managed to maintain our gardens to a high standard. And we can't forget to thank our maintenance team who managed to keep our assets in good condition.

The number of people playing social bowls in the last 12 months has been down. The summer season was very hot, and this contributed to lower numbers. Many members were also playing in pennant on both Tuesday and Saturday and this also could have been a contributing factor.

The conveners of social bowls have all worked very hard to run successful events and for this we owe them our thanks. The Tournament Committee ran and controlled a full calendar of events including the Club Championships, Pro Shot and Gala Day, Men's Health Tournament and review the conditions of play for all tournament and social bowls events.

We have an active social committee who organise many activities outside the green for the benefit of all members. They have organised bus tours, live theatre, as was the Moama trip and have course the Christmas Party. Recently they organised the 25<sup>th</sup> Anniversary dinner which was a huge success.

The house keeping team, an unnoticed but an important function, have kept our club room in great shape.

Financially, the bowls club finances are sound, and our Treasurer has provided more detail in his report. We have been able to keep any price increases to a minimum and certainly have been prudent with all our expenditures.

Thank you for the support you have given, and we will continue to work together with shared values for the Vermont South Bowls club.

## **TENNIS COACHING 2019**

Dear VSC Members,

It has been a great 2019 season for Tennis. We have had great success, progress and growth across the board in all programs this year. Many young juniors have been working

hard on their game who are now seeing the rewards for their efforts. We have approx.160 players coming regularly to tennis each week, which is giving a great vibe to the tennis club. Squad sessions have been introduced 3 times a week for Hot Shots junior levels (orange and green) and senior levels (yellow ball level), of which there are around 35 students participating. ## **TREASURER'S REPORT 2018-19**



Membership fees have remained comparable with the previous year however we are advised our affiliation fees will have an increase of 2.75% for the 2019-20 season. It is also a fact that we have over 33% of our bowls members in the Veteran classification at reduced fees. We need some younger members to balance this statistic.

Social bowling has shown an increase of 8% on the previous year which is a positive sign.

Costs of running our kitchen have increased around 15% and repairs and maintenance to the greens and gardens are 19% more than over the previous year.

Fundraising returns have remained constant and we are fortunate to have a very active social/fundraising committee who have supplemented our income with some very successful events.

'Joch's Bar' has again been well supported by members and even though it comes under the VSC umbrella it would be remiss of me to not mention the contribution Joch makes to the well being of the club.

We have installed a touch screen point of sale computer system in the bar ( "Joch 2") which enables us to have control on sales and purchases in the bar.

Upgrades to the lighting on the East Green have been completed and the effects are quite dramatic. We are reviewing the lighting on the tennis courts to upgrade them to LED. The introduction of the solar system has resulted in a reduction of our power consumption and electricity costs over the next decade or more. Our power costs with just the LED lights on the bowls east green and a change in our power supplier has reduced our costs from \$25 per day to \$15 per day.

The west green has been replaced during the break in seasons and is running very well. Due to the negotiations of the green working party we were able to pay for the green and the drainage upgrade without having to break into our term deposit.

An upgrade of the clubroom is being reviewed by the VSC which will greatly enhance our current facilities.

I would like to express my appreciation of the assistance I have received from Phil Staley, Jim Baker and Alex Blundell during the past 12 months while I was recovering from my operations and trip overseas. It is great to have such back up support.

#### NOTES TO THE FINANCIAL STATEMENTS For the year ended 30 June 2019 NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

#### 1.1 Basis of Preparation.

The committee has determined that Vermont South Club Inc. is not a reporting entity and accordingly, this financial statement is a special purpose financial statement prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act (VIC). The committee has determined that the accounting policies adopted are appropriate to meet the needs of the members.

The financial report has been prepared on an accrual basis and under the historical cost convention, except for certain assets, which, as noted, have been written down to fair value as a result of impairment. Unless otherwise stated, the accounting policies adopted are consistent with those of the prior year.

The accounting policies that have been adopted in the preparation of the statements are as follows:

#### 1.2 Inventories

Inventories are recorded at the lower of cost or net realisable value. Cost is based on first-in first-out cost method and includes expenditure incurred

in acquiring the stock and bringing them to the existing condition and location.

Net realisable value is determined on the basis of the normal selling pattern.

#### **1.3 Property, Plant & Equipment**

Items of property, plant and equipment including buildings and other leasehold property are recorded at cost less depreciation. As there is no expectation that existing leases with the Whitehorse Council will not be renewed, depreciation is applied on a straight line basis over the estimated useful life of the assets.

#### 1.4 Depreciation

Depreciation charge is a charge against the Net Income of the Club. Estimates of remaining useful lives are made on a regular basis for all assets, with annual reassessments for major items. #### 1.5 Goods & Services Tax

Transactions are recognised net of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.
